

**Study of the US Institutes for Scholars
(Séminaires d'Été pour Professeurs d'Universités Titulaires ou Associés)
Juin - Août 2015**

Descriptif de la Bourse:

6 séminaires thématiques de 6 semaines en culture et civilisation américaines:

- The Institute on U.S. Political Thought, University of Massachusetts, Donahue Institute, Amherst, MA;
- The Institute on Contemporary American Literature, University of Louisville, Kentucky, KN;
the Institute on Journalism and Media hosted by the Ohio University, OH;
- The Institute on Religious Pluralism in the United States, University of California, Santa Barbara, CA;
- The Institute on U.S. Culture and Society hosted by New York University, NY;
- The Institute on U.S. Foreign Policy hosted by Bart College, New York;

Ce programme s'adresse prioritairement aux Professeurs d'universités titulaires ou associés. Ces Professionnels travaillant dans des établissements d'enseignement supérieur souhaitant développer dans leurs institutions un programme portant sur l'un des sujets du séminaire.

Le candidat idéal serait un professionnel expérimenté avec très peu ou pas d'expérience antérieure des Etats-Unis, dont son institution d'origine chercherait à introduire ou à présenter les aspects des études américaines dans les programmes d'études, développer de nouveaux cours dans le cadre du programme, améliorer et remettre à jour les cours existants sur les Etats-Unis, ou alors offrir des séminaires ou ateliers de travail spécialisés pour des professionnels dans le domaine des études américaines liées au thème du programma.

À cet égard, et bien que les références académiques et professionnelles du candidat soient importants, sa participation à ce programme est un facteur d'égale importance car il augmentera la liste des cours en études américaines disponibles dans l'institut d'origine du candidat. ta Civilisation Américaine

Ce séminaire fournira aux participants une compréhension plus profonde des Etats-Unis, sa société, sa culture et ses institutions. La complexité et la nature hétérogènes de la société américaine sont mises en évidence aussi bien que les institutions et les valeurs qui ont permis à la nation d'accueillir cette diversité.

la Politique et la Pensée Politique Américaines

Ce séminaire fournira aux participants une compréhension plus profonde des institutions politiques américaines et des courants principaux dans la pensée politique américaine. Ce séminaire fournira une vue d'ensemble des origines, le développement et le fonctionnement de courant de la présidence américaine, le Congrès et le pouvoir judiciaire fédéral. Le participant aura l'occasion aussi d'examiner

les courants importants dans l'histoire de la pensée politique américaine, y compris la période de Fondation, le libéralisme, le républicanisme, la doctrine libertaire, le communitarisme, le conservatisme, le néo-conservatisme, etc.

La Littérature Contemporaine Américaine

Ce séminaire fournira aux participants une compréhension plus profonde de la littérature américaine récente et sa critique.

La Politique Etrangère des Etats-Unis

Ce séminaire fournira aux participants une compréhension plus profonde des fondations institutionnelles intérieures politiques, raciales, économiques et culturelles de la politique étrangère américaine avec l'attention particulière à 3^{ème} ère de post-guerre-froide, Des thèmes principaux en termes de la politique étrangère américaine seront examinés dans la lumière de l'histoire des relations internationales américaines depuis la deuxième guerre mondiale et dans la plus grande structure, d'histoire diplomatique américaine dans l'ensemble,

Le Journalisme et les Médias

Ce séminaire fournira aux participants une compréhension plus profonde du journalisme et le rôle des médias dans la société américaine. Des sujets principaux seront examinés, y compris le concept "d'une presse libre," des premiers droits d'Amendement et le rapport des médias à l'intérêt public. Les questions légales et morales posées par le journalisme seront incorporées dans chaque aspect de ce séminaire.

Le Pluralisme Religieux

Ce séminaire fournira aux participants une compréhension plus complète de la société américaine et de sa culture, le passé et présent, par un examen du pluralisme religieux aux Etats-Unis. Des sujets aussi divers que démographie et sociologie, politique et religion, les guerres culturelles, les Amérindiens, La présence musulmane, Le judaïsme américain, les effets de l'immigration asiatique, l'évangélisme chrétien, les nouveaux mouvements religieux ou religion seront abordés lors de ce programme.

Conditions :

- Etre de nationalité Algérienne et résident en Algérie;
- Etre professeurs d'universités titulaires ou associés;

- Etre soutenu par son institution dans cette démarche;
- Les candidats doivent avoir une excellente maîtrise de la langue anglaise (à l'écrit et à l'oral).

Processus de sélection :

La section des Affaires publiques organise la présélection des candidatures sur dossier et organise un entretien oral dans ses locaux. Un entretien obligatoire aura lieu la première semaine de janvier 2015. La sélection finale est faite aux Etats-Unis parmi des candidats du monde entier.

Study of the United States Institutes (SUSI) For Scholars
June-August 2015

Scholar Institutes are designed to **strengthen** curricula and **improve** the quality of teaching about the United States overseas. These Institutes host multinational groups of university faculty. Each Institute is thematically focused on a field or topic of U.S. studies. Participants interact with American scholars, meet with experts in their disciplines, visit civic institutions, and explore the diversity and culture of the United States. Scholar Institutes typically take place during the months of June, July, and August.

1. US Political Thought:

The Institute on US Political Thought provides a multinational group of 18 experienced and highly-motivated foreign university faculty and related professionals with a deeper understanding of U.S. political institutions and major currents in American political thought by focusing on the interplay between ideas and institutions in shaping the contemporary American polity. The Institute provides an overview of the origins, development, and current functioning of the American presidency, Congress and the federal judiciary. Examination of political institutions is further expanded to include the two-party system, the civil service system, interest groups, and the welfare/regulatory state. Participants also examine competing strains in modern American political thought/culture, such as liberalism, republicanism, libertarianism, communitarianism, conservatism, neo-conservatism, etc.

The Institute reviews the provenance and trajectory of these different intellectual strands or movements, and highlights how they have intersected with American political institutions to shape public discourse and public policy formulation in the contemporary United States.

2. US Contemporary American Literature:

The Institute on Contemporary American Literature provides a multinational group of 18 experienced and highly-motivated foreign university faculty and scholars with a deeper understanding of contemporary American literature. Its purpose is twofold: 1) to explore contemporary American writers and writing in a variety of genres; and, 2) to suggest how the themes explored in those works reflect larger currents within contemporary American society and culture. The Institute explores the diversity of the American literary landscape, examining how major contemporary writers, schools, and movements reflect the traditions of the American literary canon. At the same time, the Institute exposes participants to writers who represent a departure from that tradition, and who are establishing new directions for American literature.

3. Journalism and Media:

The Institute on Journalism and Media provides a multinational group of 18 experienced and highly-motivated foreign journalism instructors and other related specialists with a deeper understanding of the roles that journalism and the media play in U.S. society. The Institute examines the rights and responsibilities of the media in a democratic society, including editorial independence, journalistic ethics, legal constraints, foreign policy issues, and media business models. The Institute includes strategies for teaching students of journalism the basics of the trade: researching, reporting, writing, and editing.

The program also highlights technology's impact on journalism, addressing the influence of the Internet, the globalization of the news media, the growth of satellite television and radio networks, and other advances in media that are transforming the profession.

4. Religious Pluralism in the United States:

The Institute on Religious Pluralism in the United States provides a multinational group of 18 experienced and highly-motivated foreign university faculty and related practitioners with a deeper understanding of religious pluralism in the United States and its intersection with American democracy. Employing a multi-disciplinary approach, and drawing on fields such as history, political science, sociology, anthropology, and law, the Institute explores both the historical and contemporary relationship between church and state in the United States. Additionally, the Institute examines the ways in which religious thought and practice have influenced, and been influenced by the development of American-style democracy; examines the intersections of religion and politics in the United States in such areas as elections, public policy, and foreign policy; and explores the sociology and demography of religion in the United States today, including a survey of the diversity of contemporary religious beliefs and its impact on American politics.

5. U.S. Culture and Society

The Institute on U.S. Culture and Society provides a multinational group of 18 experienced and highly-motivated foreign university faculty and other specialists with a deeper understanding of U.S. society, culture, values, and institutions. The Institute examines the ethnic, racial, economic, political, and religious contexts in which various cultures have manifested themselves in U.S. society, and the ways in which these cultures have influenced social movements throughout U.S. history.

The program draws from a diverse disciplinary base, and provides a model of how a foreign university might approach the study of U.S. culture and society.

6. U.S. Foreign Policy

The Institute on U.S. Foreign Policy provides a multinational group of 18 experienced and highly-motivated foreign university faculty and related professionals with a deeper understanding of how U.S. foreign policy is conceptualized and enacted with emphasis on the post cold war era. The Institute examines the intersection of ideas and structures in the development of U.S. foreign policy, but focuses primarily on the main philosophical traditions on which U.S. foreign policy has been based; the grand strategies and frameworks that have been developed out of these philosophical trends; and, what actors--both governmental and non-governmental--shape U.S. foreign policy from its conceptualization to its enactment. An overarching goal of the Institute is to illuminate the relationship between U.S. policies and the political, social, and economic forces in the United States that constitute the domestic context in which such policies are debated, formulated, and executed. Lastly, the Institute is structured to give attention to U.S. policy both globally and in particular geographic areas, by examining the role of U.S. foreign policy within the context of international relations and international institutions.
